Our shared observance of the season of Lent has become, over two thousand years of church history, quite stylized. We come to the church on Ash Wednesday—forty days, minus Sundays, before Easter morning—to repent of our sins and begin a special time of fasting, prayer and particular attention to Jesus on the road to the cross. We bury the Alleluia, we clothe the sanctuary in purple, and some of us take on a ritual fast—abstaining from some of the rich things in life. I love these traditions, and I am eager to see how they play out at St. Mark's.

Still, sometimes the stylized manner of our observance can obscure the fundamental reason for Lent. Simply put, we listen intently to the stories about the life of Jesus for forty days. The great traditions of the church are beautiful, of course, but anyone can observe a holy Lent in a myriad ways. Maybe there is a special book of devotions that you'll place by your bedside for prayer before sleeping. Maybe there is a podcast or audiobook you've been meaning to listen to on your commute. Perhaps it is making more of an effort to be in church Sunday morning and to participate in all the Lenten opportunities here at St. Mark's. In whatever way you decide to listen to the stories about the life of Jesus—big, small, stylized, informal—you are observing Lent.

The earliest Christians used this special time to train new members in the mysteries of our faith. The students, called catechumens, were instructed in the scriptures, the creeds, the sacraments until

they were ready to become full members in the Christian community on Easter morning. In keeping with that ancient tradition, if you have any desire to be Received into the



Episcopal Church, be Baptized (if you haven't been already) or be Confirmed, please contact the office and leave a message for me. I'll be glad to help you prepare. Some people find Lent to be a time of special confession. If you desire the rite of Confession and Absolution, please let me know. I want to be available to support you in making Lent a spiritually grounding and meaningful time.

Lent can be one of the most rewarding seasons of the Christian faith. I look forward to sharing this holy time with the entire parish.

## Deacon's Corner

*Now there are a variety of gifts, but the same Spirit; and there are a variety of services, but the same Lord...to each is given the manifestation of the Spirit for the common good.*  
1 Corinthians 12: 4-6

**A**s we continue in the new year with a new pastor, I find myself thinking of all the gifts that reside in our parish. We have many folks who give of themselves to so many ministries of an amazing variety. We have individuals whose gifts are largely spent within the walls of the church, while some are embedded in our community and the wider world. Furthermore, we find ministries that are very charitable in nature, and those whose focus is of a more justice seeking nature. Finally, some devote their time helping largely on a one-to-one basis, while others seek to change communities as a whole.

As we heard in Corinthians on Sunday, January 17, all these gifts and their manifestations as ministries, are important, and all come from the Lord through the Spirit. Each of us is gifted in distinctive ways. The important thing is to recognize our gifts and use them to build up God's Kingdom. We are called to help others perhaps individually, or as part of movements that address injustice on a worldwide scope.

That is why we, I believe, are also called to live and minister in communities that can hold and make manifest all our gifts for the

common good. I know people who are quick to criticize the church for only being interested in charity, leaving advocacy for justice to others. I confess that I have made that point myself in the past. But as I see in my own community of St. Mark's, both charity and justice-seeking being actively pursued, I am less worried.

I see in the church more efforts, not just in St. Mark's, but in other places as well, a new understanding of the importance of both endeavors. I see an understanding of the necessity for both charity and justice in our world. I also have learned that some of us have gifts that mesh with charity ministries, while others have a burning passion to bring more justice to our society.

Corinthians reminds me that this has been so since the beginning of the early church—many gifts to all individuals, given by the Spirit to enrich and enliven one body. Thanks be to God.

We have received a limited amount of Lenten Devotionals. They will be available on a first come, first served basis at the back of the church beginning Sunday, Feb. 7.




## Women's Book Group

# Adult Formation Lenten Program

## “The Heavens Are Closed”—When God Abandons Us



**T**here are times in the lives of individuals, communities and the world when God seems to have forgotten about all those promises and covenants. Then we are left to face the darkness alone and ask, “Why has God left us? What have we done wrong? Where is our God?” This year’s St. Mark’s Lenten Program will seek answers to those questions in the experiences of Christian and Jewish communities and in the dark nights of individual souls—both sinners and saints. The answers of these people may surprise and help us to trust that hope is always a part of our response to God. Classes will be held on five Thursday nights in Lent. A light supper will begin at 5:30 p.m. and sessions will be from 6:15 to 6:45 p.m. Please let Sara or Deacon Michelle know if you intend to join us for the meal. A suggested donation of \$8 is requested to cover the food. All are welcome!

### **Feb 18—“My God, my God, why . . . ?”: The New Testament Experience**

The Rev. Julian Hills will lead this session to explore those times in the New Testament when the first Christians experienced isolation and abandonment by their fellow believers and even, so it seemed, from God.

### **Feb 25—“When You Go Down”: The Experience of Exile**

Using classic Jewish theology and depth psychology, Rabbi Yoni Meadows will explore how the Jewish people tried to make sense of their seeming abandonment by God in the repeated exiles from the Promised Land.

### **March 3—“Dark Nights of the Soul”: The Mystical Experience**

Dr. William Wainwright, Professor of Philosophy Emeritus at the University of Wisconsin–Milwaukee, will discuss the lives of two medieval Christian mystics, St. John of the Cross and Teresa of Avila, to discover how those dark nights can transform our souls.

### **March 10—“Silence”: Experiencing an Absent God**

Dr. William Wainwright will lead an exploration of two different stories of a silent God—one fictional, from the novel “Silence” by Shusaku Endo, and the other the very real absence of God in Mother Teresa’s spiritual life.

### **March 17—Radical Resistance: Experiencing Hope in Suffering**

The Rev. Ian Burch, rector of St. Mark’s, will explore the theme of radical, sometimes foolish, hope in the midst of suffering. Drawing on his years in hospice and emergency room chaplaincy, Fr. Burch will explore the common themes of resilience and faith in ancient scriptures as well as in the stories of the people of God today.

## Common Ground's Spring Election Strategy



Common Ground will focus this spring on increasing voter turnout for the City of Milwaukee mayoral and aldermanic election that will take place on April 5. The effort is part of

the group's Milwaukee Neighborhoods Now (MNN) campaign. Because Common Ground is a nonpartisan 501(c)3 organization, it will not endorse candidates. Instead, its leaders will ask candidates to endorse its platform goals for specific capital improvement in city neighborhoods.

After the primaries, at a major citywide forum on Tues., Mar. 15, Common Ground will invite the mayoral candidates to respond to its platform. Similar forums will be held in selected aldermanic districts. (Fourteen of the 15 members of the Common Council face a contested election this year.)

Regardless of who ultimately is elected, Common Ground plans to work in the fall with them to implement its goal of including in the 2017 City of Milwaukee budget \$80 million that will bring to reality the neighborhood improvement goals on its own platform.


### Digging in at St. Mark's

The MNN platform is being crafted from suggestions at small group "DIG" (Discovery in Groups) sessions held across the city in January by member organizations, including St. Mark's. Total participation was about 600 people. At these sessions, participants discussed one question: "If we had \$100

million in Capital Improvement Funds for Milwaukee and your neighborhood, how should these funds be spent?" The topic of capital investment (as opposed to programs) was stressed because Common Ground feels that if our city found a way to put \$80 million of public money towards a new Bucks arena, then we deserve to see a parallel investment in our neighborhoods.

The St. Mark's Common Ground core team held two DIGs in January, one for parishioners and one for neighbors. Attendance was very good, with both sessions having between 12 and 15 participants. Many observed that it was refreshing and hopeful that Common Ground was going to take these suggestions to make up a platform for the 2016 elections. Some of the suggestions included investing in the infrastructure on Downer Avenue to encourage new retail investment and providing better athletic facilities for Milwaukee schools and parks. An indoor soccer facility was a very popular nomination on the East Side as well as on the South Side, where the stadium would be located.

The material generated in conversations here was analyzed and combined with reports from other DIG's to build a preliminary MMN platform. The specific suggestions fell into three major categories: Fixing (e.g., matching grants for home improvements and revitalization for Center Street between 35th and 60th streets), Building (e.g., an indoor soccer arena on the South Side and renovation of

three school athletic fields that were part of the Fair Play campaign) and Beautifying (e.g., tree planting, community gardens and public art).

### From 600 conversations to 4,000


Between now and the April elections, Common Ground will conduct a door-to-door voter education campaign designed to increase voters' engagement with local issues and thus increase voter turnout. At a members' assembly on Jan. 26, some 260 Common Ground leaders committed to canvassing in shifts on six weekends between Feb. 20 and the April 5. If 20 voters are engaged in conversation by 20 volunteers during each of those two-hour shifts, we will have multiplied the conversations in DIG sessions to over 4,000 conversations with potential voters. The focus will be on six key city wards in three aldermanic districts where voting is typically much lower in municipal elections than in presidential elections.

Common Ground members' motivation for the platform and neighborhood walks comes not just from the arena debate but also from a desire to

“change the way Milwaukee does politics,” as one leader told the January 26 assembly. MMN campaign co-chair Maria Barker, a South Side leader, urged the crowd to elevate the way politics works in Milwaukee, saying “We want to make ‘by the people and for the people’ a reality, not just a slogan.”

# Report on the Annual Meeting



Our annual meeting on January 31, 2016, was a landmark for St. Mark's. Along with the usual packet of ministry and financial reports, the election of new lay leaders, and Sara's always entertaining slide show, we expressed our gratitude to Frank West for his faithful years as a warden these last four years, and we celebrated Fr. Burch's first time presiding at St. Mark's annual meeting.

## Rector's Remarks

Father Ian Burch's remarks at the meeting were full of optimism about our parish's future. Last fall, in his very first interview with us, he spoke of St. Mark's as "a gem of a church," and he expanded on this theme again at the meeting, saying "We have a gorgeous church full of whip-smart, faithful people sitting on the prettiest block in Milwaukee." Looking toward the year ahead, he spoke of four pillars of church life that will be a focus in 2016: social justice, music and liturgy, children's formation, and adult formation. Describing St. Mark's as a community with "an embarrassment of riches," Fr. Burch said, "There is no reason under heaven that we will not attract newcomers who want to be in community with the fantastic people who are already here—who want to deepen their relationship with God and with each other.

## 2016 Budget

Treasurer Barbara Costanzo presented and explained the deficit budget adopted by the Vestry at its January meeting. We had an overage during 2015 because we relied on supply clergy all year instead of only six months, but this good news, she said, is not something to celebrate. Our pledging has trended downward in recent years while our costs go up, she said. The result is a conservative budget with a \$62.5 thousand deficit. As we move forward, the Vestry will be monitoring finances carefully and looking for additional sources of income.

## Elections

The parishioners present adopted unanimously the slate presented by the Vestry. It included two wardens, four new Vestry members, and four delegates (including two alternates) to the annual diocesan convention. Normally, only three people are elected to the Vestry each year, but this year we find ourselves having to replace not only the three outgoing members but Brad Kirschner as well. He and his family will be moving to Vashon Island, Washington sometime in the summer. (We will miss them!) The Vestry members completing their terms are Nikki Domenget, Richard Runkel, and Jane Shero, all of whom served for the past three years, for which they received applause and thanks.



Here is a list of those elected. More information about each is available in the packets passed out at the annual meeting and the e-blasts sent out during the two weeks preceding the meeting. (If you missed the meeting, you may request an electronic copy of the full packet from the office.)

**Senior Warden, Virginia Chappell** (*one year term, renewable up to 3 yrs.*)

Virginia, a retired Marquette English professor, has served as Junior Warden for the past two years and co-chaired (along with Frank West) the Search Committee that called Father Burch.

**Junior Warden, Ronald Tunis** (*one year term, renewable up to 3 yrs.*)

Ron, recently retired, is a member of the choir, men's fellowship, prayer and healing ministries, and a past vestry member.

### Vestry

**David Kiger** (one year term, renewable for 2 more years), a doctoral student in Historical Theology at Marquette. He and his wife Hannah have been members of St. Mark's since 2013. They love the welcoming spirit of St. Mark's and how active the parish is in the life of the city.

**Tom Lacy** (3-year-term) and his wife Jane have been members of St. Mark's since 2004 along with their daughter Catherine (11) and son Marcus (8). Tom was previously a Vestry member in the late 2000's. Professionally, he is a Managing Director in Baird's Financial Sponsor Group, where he works with private equity firms as they consider sale transactions, acquisitions, and public stock offerings.

**Ellie Mixer-Keller** (3-year term) was baptized at St. Mark's and raised here in a very active St. Mark's church family. She taught Sunday School as a teenager, was married here, and her children, Elizabeth and Jason Keller, attended the church school. She has a background in advertising and marketing, and helps spread the word about St. Mark's through social media.

**Andrew Muriuki** (3-year term), born in Kenya, comes from long line of Anglicans. He moved to Milwaukee in 2007 from Columbia, Missouri to do his post-doctorate fellowship at UWM. Professionally, he is a behavioral health researcher and data analyst. His research interests include child
